**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,

PROGRAM FOR BOWLINE STREET  
SANITARY SEWER REHABILITATION**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has previously appointed various engineering firms to the 2024 engineering pool; and

**WHEREAS**, the Township is in need of an Engineering firm to provide Professional services for the design, bidding and construction management for the 2024 Sanitary Sewer Capital Improvement Program for the Rehabilitation of the Bowline Street; and

**WHEREAS**, the Township’s Engineer, Kurt Otto, recommends that Remington and Vernick do the Scope of Services as per attached at a rate not to exceed \$22,500.00; and

**WHEREAS**, the Township accepts the recommendations of its Township Engineer; and

**WHEREAS**, that the Chief Financial Officer (“CFO”) does hereby certify the availability of funds with respect to awarding Remington and Vernick for the Professional Services of the 2024 Sanitary Sewer Capital Improvement Program, Bowline Street Sanitary Sewer for an amount not to exceed \$22,500.00;
