**A RESOLUTION OF THE TOWNSHIP COMMITTEE OF  
THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN  
AND STATE OF NEW JERSEY AWARDED BID FOR  
THE 4<sup>TH</sup> STREET PUMP STATION IMPROVEMENTS  
RE-BID TO SUB-LEVEL INSTALLATIONS INC.**

**WHEREAS**, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (“the Township”) has solicited bids for the 4<sup>th</sup> Street Pump Station Improvements project Re-Bid; and

**WHEREAS**, the Township’s professional staff reviewed the bids and the Township’s Consulting Engineer Alaimo Group issued a review memorandum dated November 29, 2024, a copy of which is attached hereto and made a part hereof, recommending award of the bid to the lowest responsible bidder Sub-Level Installations Inc., 240 West 22<sup>nd</sup> Street, Ship Bottom, NJ 08008; and

**WHEREAS**, the Township accepts the recommendations of its professional staff; and

**WHEREAS**, the funds, in an amount not to exceed \$268,050.00, are hereby appropriated in the following line item appropriation(s), and is hereby certified by the Certified Municipal Finance Officer as of the adoption of this resolution.
