**A RESOLUTION OF THE TOWNSHIP COMMITTEE OF

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (“the Township”) solicited bids for the SCADA Equipment and Software upgrade and installation (“the Project”); and

WHEREAS, the Township’s professional staff has reviewed the bids, and the Township finds it can award the bid to the lowest responsible bidder subject to the Township’s budgetary restraints; and

WHEREAS, the Township accepts the recommendations of its professional staff; and
