Diane Grockenberger: 108 Redwood Drive – Thank you for allowing us to come up with something between now and December to work on this situation. We need to work together.

Jared March: 117 Cypress Lane – Mentioned that he is a Hospice Chaplain and meets with people everyday that have no financial plan if a spouse gets sick. Look at our age group in Pinewood and Brighton. 50% worry about long term care. They are in need for help. Please protect this group.

Carrie Dione: 57 Old Main Shore Rd. – Founder of Barnegat Pride. Thanked the Chief and his staff for their support. Special thanks to Lt. Venuto, Captain Parsley, & Ptl. Santos. Pride festival on May 31st. Thanked police because of threats and for protecting us. Thanked all donations. Asked Mayor to be a speaker. Would like a paved road on Lower Shore Rd.

Tom Randozza: 4 Spring Lake Ct. – Congratulated our Town Administrator for only increasing our taxes by a penny. Thanked committee for watching our community. Our sports program is the best. Appreciate the program. We are #14 best town in Ocean County.

An Ordinance Repealing Chapter 64 of the Township Code entitled "Rent Leveling"

Motion to open Public Comment: Al Bille Second: Joseph Marte

MaryLynn Gardner: 190 Chestnut Dr. – Read a statement on Poverty Rate. Older American Act was passed in 1965. Its goal was to support older people to live at home. We need more help, not less. Please table tonight!

John Murrin: 38 Pierhead Dr. – Super job on fire and Nixle. The Ordinance has many other things that protect the residents not just increase. Each party can pay for their Attorney fees.

Eileen Court: 147 Brighton Rd. – Questioned, why not just leave it in place? If state plan goes through then we can talk about it. Why are you putting an end date? What is the reason we are doing this? So after the New Year the Township is no longer responsible for handling rent control? Very unfair!

Al Bille: Township paid \$18,000 last year in legal fees and we were sued twice! When you have a Rent Leveling Board you must have an Attorney and it becomes costly. It becomes a burden to the entire town. We are giving you time.

Lorraine Ferrara: 121 Cypress Lane – Curious of how long since the Ordinance been on the books? Has the Township been sued since 2006 because of this Ordinance? We were mislead on this meeting. It was told to us that Ordinance was going to be tabled. There was a miscommunication! I had sent out packages to you all. Not very happy with the support of this Township!

Margot Kagan: 156 Chestnut Dr. – I am a Project Manager. These people are very poor! This is the wrong time to dissolve this board. It can cause homelessness. Do you really think this is what your community wants? Ask the landlord to provide funding. Not what people want!

Diane Grockenberger: 108 Pinewood Estates – The Township has been sued for quite a bit. We do not have a landlord that we can work with. We asked, we begged, we pleaded, we did everything that you said and you gave us until December. They need to prove why to keep the Rent Leveling Board.

Michelle Woodriff: 5 Ann Ct. – Average 500 rent x 12 months x 18%. We are paying \$297,000 a year collectively in taxes. What you are not paying is our electric, water, septic, roads, trash, etc. We are paying them for the whole community. You can afford to pay a lawyer for our concerns. We are footing \$1,000,000. You are paying \$18,000. We are paying our way! Save our rent control!

Meaghan Well: 3 Nancy Lane – Sad to hear you are dismantling this. We don't know that you are going to get sued by anyone else. We pay for everything. We are asking for dignity and protection. Sadden by your body language that you don't care. I have to protect Hometown America. We need help and protection! I teach value and love.

Diane Schlagel: 32 Kimberly Dr. – I am offended that you are saying we are a problem. Septic took 2 years. In the beginning the Rent Leveling Board helped Brighton with Hometown America. Hometown America can sell our property and we wouldn't have that protection. Think about holding off with voting yes.

Ron Naples: 153 Brighton Rd. – Mr. Bille this will be our legacy. When Mr. Pipi was Mayor he would always say his #1 job was to protect the citizens of Barnegat. We do not know what the government will do. We should make it better, not run away. Make the rent better for all renters. Does it have a brain? Is it logical? Doesn't make sense not to protect the citizens of your town. Does it have a heart? I do not see a lot of heart. I do not see courage. Protect your citizens! Instead of fighting a good law we ran for coverage. Hope I see courage tonight to withdrawal this Ordinance!

John Murrin: 32 Pierhead Dr. – Last meeting was a 3 to 2 vote. I have a solution and the town will be out of it. Do it the same way as the zoning board.

Mr. Cirulli: Mentioned to Pinewood that they need their own Attorney. That's the issue.

Meaghan Well: 3 Nancy Lane – Asking about Attorney presence. Mr. Bille explained how to go about it.
