**A RESOLUTION OF THE TOWNSHIP COMMITTEE
OF THE TOWNSHIP OF BARNEGAT, COUNTY OF
OCEAN AND STATE OF NEW JERSEY
AUTHORIZING REDUCTION OF THE
PERFORMANCE GUARANTEE FOR WATER
SYSTEM FACILITIES TO WALTERS
DEVELOPMENT, CO. FOR OCEAN ACRES
DEVELOPMENT PHASE 14**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has received a request from the Developer Walters Development, Co., (“Developer”) for reduction of the performance guarantee for water system improvements for Ocean Acres Development – Phase 14 (the “Project”); and

WHEREAS, the Developer posted a performance guarantee which is Bond #PB00459500137 which consisted of a bond/letter of credit in the amount of \$231,491.70 and a cash guarantee portion \$25,721.00; and

WHEREAS, the Developer has requested the performance guarantee be reduced in accordance with the provisions of the Municipal Land Use Law N.J.S.A. 40:55D-1 et seq.; and

WHEREAS, the Township’s Consulting Engineer CME Associates issued a review memorandum dated May 21, 2025, a copy of which is attached hereto and made a part hereof, recommending reduction of the performance guarantee as follows:
