Marty Weber: 290 Rt. 72 – Affiliated with Jeff's Camp. Few years ago went to Pinelands Commissioner for help for homes for our Vets. We were turned down. Want to change our plan. Want to help our Vets! Asking for you to help and fight. Would like to put up a small building for a counseling center for our Vets. Will submit a plan again. There will be no housing. Would like to move forward with this.

Frank Belluardo: 196 Chestnut Way – Thanked Mayor Cirulli and Pat Pipi on behalf of the people of Pinewood for helping with the ordinance on Rent Leveling. Showed you really care about the people. Thanked Mr. Cirulli for being a good human being and the effort you put out when there was a problem with the septic. Complimented Mr. Dasti for his value and efforts. Checking with the NJ Bar Association, any ordinance or law can be challenged and taken to court. Committee failed to realize that the Township Committee has no right to overturn the decision of the board. Just wanted you to know how I feel. You denied us the right to live in peace and harmony.

Diane Grockenberger: 108 Redwood Dr. – Asked where is Valley View Estates? Kurt Otto answered that it is off of Benjamin Court.

Have been reading about low income housing. Can only find in Lacey Township. Kurt mentioned that we have affordable housing here in Barnegat. Mr. Dasti explained you need to qualify depending on your income level.

Will Barnegat Crossing III have affordable housing? Kurt replied, he doesn't believe so. Where is the water tower going?

Kurt said it will be going to Sea Crest Pines to the west. If you want water you would need Pineland approval and environmental study.

Al Bille – Explained affordable housing per planning board

Will we go live stream? Donna mentioned that they are working on it and hopefully by July.

Tom Randazzo: 4 Spring Lake Ct. – Thanked committee. Barnegat is a very desirable town. Congratulations on doing a good job!

Al Bille: Spoke about how the taxes are only a \$33 difference between Stafford and Barnegat and \$59 from Lacey. Lacey gets \$11,000,000 from the plant. Stafford's taxes are going up 1.7% and we are only going up 1%. Tom and Marty do a great job to keep taxes down.

Ray Lescheck: 1 Redwood Dr. – Questioned about the upper deck at the gazebo, still nothing happening. Kurt responded that they are currently waiting for a grant. The first level will be open. What's happening with Meadow Edge Park?

Al Bille said he is working with DPW and recreation and explained the work that is being done with Meadow Edge.

Also have written some rules for Rent Leveling. Mr. Dasti took literature from Ray.

Carl Reitman: 115 Chestnut Way – What is the affordable law?

Mr. Dasti explained the law on affordable housing. It goes by income level. Will send information on the income levels to Mr. Reitman.

Could the committee help the people of Pinewood stay where we are with affordability?

Tom Randazzo: 4 Spring Lake Ct. – Governor Murphy has allowed 300,000 illegals to live here for free.
