

RESOLUTION 2025-278

A RESOLUTION AUTHORIZING THE MEMBERSHIP PARTICIPATION IN AN INTERLOCAL AGREEMENT FOR COOPERATIVE PRICING SYSTEM BETWEEN THE TOWNSHIP OF BARNEGAT AND REGION 8 EDUCATION SERVICE CENTER #225-950

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, Region 8 Education Service Center, (located in Camp County, Texas) Cooperative Pricing System (ID # 225-950), has offered voluntary participation in an Interlocal Agreement for Cooperative Pricing System for the purchase of goods and services; and

WHEREAS, on this date, August 5, 2025 the governing body of the Township of Barnegat, County of Ocean, State of New Jersey duly considers participation in a Cooperative Pricing System for the provision and performance of goods and services; and

WHEREAS, the parties agree to comply fully with all applicable federal, state and local statutes, ordinances, rules, and regulations in connection with the programs contemplated under this agreement.

WHEREAS, the Township of Barnegat, pursuant to N.J.S.A. 40A:11-1 et seq. may, by resolution and without advertising for bids, purchase any goods or services under the Region 8 Education Service Center Cooperative Pricing System for any contract entered into on behalf of the Township of Barnegat; and

WHEREAS, The Region 8 Education Service Center shall be responsible for complying with the provisions of the *Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)* and all other provisions of the revised statutes of the State of New Jersey and by the law in the State of Texas; and

WHEREAS, it is the desire of the Township of Barnegat to join the Region 8 Education Service Center Cooperative Purchasing System to purchase goods and services, to make the procurement process more efficient and to provide cost savings to the Township.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. That the governing body of the Township of Barnegat hereby authorizes the Mayor, and Municipal Clerk to sign a member participation agreement with the Region 8 Education Service Center Cooperative Pricing System id #225-950
2. The Township shall be responsible to ensure that the goods and or services procured through the Region 8 Education Service Center Cooperative Pricing System comply with all applicable laws of the State of New Jersey , Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey and the State of Texas
