

**RESOLUTION NO. 2025 – 280**

**RESOLUTION OF THE TOWNSHIP OF  
BARNEGAT, COUNTY OF OCEAN, STATE OF  
NEW JERSEY, AWARDING BID FOR SOLID  
WASTE COLLECTION TO MEADOWBROOK  
INDUSTRIES, LLC FOR A FIVE-YEAR TERM  
BEGINNING JANUARY 1, 2027 AND ENDING  
DECEMBER 31, 2031.**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has solicited bids for solid waste collection services; and

**WHEREAS**, solicitation for bids was for collection services to begin January 1, 2027 and for the bids to include options for a 1-, 3- or 5-year contract terms with various options; and

**WHEREAS**, bids were solicited in accordance with the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, in response to the solicitation of bids, the Township received one bid from Meadowbrook Industries, LLC; and

**WHEREAS**, after the bid was received and reviewed by the Township’s professional staff, the Township has determined that it can award the contract to the sole bidder Meadowbrook Industries, LLC, for a 5-year contract as follows:

**WHEREAS**, a copy of the bid is on file in the Office of the Township Clerk and can be inspected during normal business hours; and

**WHEREAS**, the bid is awarded subject to the Township’s budgetary constraints; and

**NOW, THEREFORE, BE IT RESOLVED** on this 5<sup>th</sup> day of August, 2025 by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The bid is hereby awarded to Meadowbrook Industries, LLC, for a 5-year contract beginning January 1, 2027 and ending December 31, 2031 pursuant to the bid submitted by the bidder which is incorporated by reference and pursuant to the schedule below:

3. The bid is awarded subject to the Township’s budgetary constraints.
