Barnegat Township Road Opening Bond and Permit Application Instructions

- * All road openings require a Road Opening Bond (Refundable 2 year from the completion of road work)
 - * The Road Opening Bond is only good for one opening. Therefore, if you are opening more than one hole, you must post bonds for each opening.
 - * Road openings that are 100ft or less require a \$2,500.00 Bond. Road openings over 100ft require \$2,500.00 plus \$20.00 per foot over 100. This is required for each road opening.
 - * All road openings require a \$300.00 Inspection Fee for the Initial Road Inspection and \$300.00 for the Final Inspection of the Road (to be performed one year from completion)
 - * Any Water and/or Sewer Tap must be inspected by the Township Engineer at the time the work is being performed. This requires an additional \$500.00 Inspection Fee for each tap.
 - * Some road openings may require the presence of a Traffic Control Officer. If it is determined that an officer is necessary, then payment for their services is mandatory. Payment amount will be quoted by a Barnegat Township Traffic Control Officer.
 - * Road Opening Bonds are obtained in the Township Clerk's Office.
 - * Checks shall be made payable to the Township of Barnegat.
 - * Requests for Final Inspection and Bond Releases shall be made in writing and submitted to the Municipal Clerk after two (2) year of the completion of work performed.
- * A plan showing proposed work and applicable construction details shall be provided for review. Construction details can be found at http://www.nj.gov/dca/divisions/codes/codreg/pdf_regs/njac_5_21.pdf

Step 1: Obtain this packet and a Curb Cut Application along with required fees from the Construction Office.

Step 2: Complete the Bond Application and Checklist.

Step 3: Submit Road Opening Bond and Inspection Fees to Barnegat Clerks Office.

Step 4: Bring completed applications and payment Receipts to Construction Office.

Step 5: Submit Applications, **Plan**, and Permit Application Fee

Step 6: You will be contacted by the Construction Office when your permit is approved & ready To be picked up.

Step 7: Contact the Township Engineer to schedule Water and Sewer Taps – The Engineer must be present at time of connection.

Step 8: 2 years from completion submit a written request for release of Bond to Clerk's Office
