**A RESOLUTION OF THE TOWNSHIP
COMMITTEE OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN AND STATE OF
NEW JERSEY AWARDING BID FOR THE 2026
TAHOE POLICE VEHICLES**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) solicited bids for the purchase of two (2) 2026 Chevrolet Tahoe PPV 4WD SUVs and one (1) 2026 Chevrolet Tahoe SSV 4WD SUV; and

WHEREAS, bids were solicited in accordance with the New Jersey Local Public Contracts Law N.J.S.A. 40A:11-1 et seq.; and
