**A RESOLUTION OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN AND STATE OF NEW JERSEY
GRANTING PRELIMINARY SANITARY SEWER SYSTEM
FACILITIES APPROVAL TO M&T AT 547 MAIN, LLC FOR
BLOCK 146.02, LOTS 9.02, 10.01 AND 11; BLOCK 147, LOT 1;
BLOCK 148, LOT 1; BLOCK 149, LOTS 1 AND 2; BLOCK 150,
LOTS 1, 1.01, 2, 3, 4 & 5 AND BLOCK 151, LOT 1**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (“the Township”) has received an application from the developer M&T at 547 Main, LLC for preliminary sanitary sewer system facilities approval for a Wawa food market and fueling station to be located at 547 Main Street, Barnegat, New Jersey otherwise known as Block 146.02, Lots 9.02, 10.01 and 11; Block 147, Lot 1; Block 148, Lot 1; Block 149, Lots 1 and 2; Block 150, Lots 1, 1.01, 2, 3, 4 and 5 and Block 151, Lot 1 (“the Property”); and

WHEREAS, the Township’s Engineer Kurt J. Otto, P.E., has reviewed the application and issued a review memorandum dated July 9, 2026, a copy of which is attached hereto and made a part hereof, recommending preliminary approval subject to the terms set forth in the review memorandum; and

WHEREAS, the Township accepts the recommendations of its professional staff.

NOW THEREFORE BE IT RESOLVED this 4th day of August, 2026, by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:
